The nominations of eligible officers along with, (a) their bio-data in the prescribed proforma (**Annexure-II**) duly attested, (b) Attested copies of Annual Confidential Reports for the last five years (2016-17 to 2020-21), (c) details of major and minor penalties for the last 10 years and (d) Certificate(s) of Integrity, Vigilance and Cadre Clearance, may please be forwarded to this Academy **through proper channel** at the earliest and in any case not later than 60 days from the date of issue of this letter. The details including prescribed proforma and eligibility conditions etc are also available of North Eastern Police Academy’s website ([htt://nepa.gov.in/permanentpost.html](http://nepa.gov.in/permanentpost.html)).

4. Incomplete application in any respect or those not accompanied by the documents / information mentioned in para 3 above will **NOT** be considered. The cadre controlling authorities may ascertain that the particulars sent by the officers are correct as per the service record. While forwarding the nominations for the post of Inspector (ToT), it may kindly be ensured that the nominated officers should not be in pay scale higher than the pay scale of the deputation post, i.e., level-6 in the pay matrix. However, selected personnel may elect to draw either the pay in the scale of pay of deputation post or his basic pay in the parent cadre as per rule.
