G.S.R. 177.—In recreise of the powers conferred by the provision to article 309 of the Constitution, the President hereby makes the following rules regulating the method of recruitment to Group 'C' and Group 'W posts in the Office of the Commandant, North Eastern Pouce Academy, Barapani, Meghalaya:—

- 1. Short title and commencement.—(1) These rules may be called the North Eastern Prince Academy, Barapani (Group 'C' and Group 'D' Posts) Ferruitment Rules, 1983.
- (2) They shall come int, torce on the date of their publication in the Official Gaza, a
- 2. Application.—These rules shall apply to the posts specified in column 1 of the rehedule annexed hereto.
- 3. Number classification and scales of pay.—The number of posts, thir classification and the scales of pay attached thereto shall be as specified in columns 2 to 4 of the said schedule.
- 4. Method of recruitment, age limit and qualifications.— The method of recruitment age limit, qualifications and other matters relating to the said posts shall be as specified incolumns 5 to 13 of the said Schedule. (

- 5. Disqualification. -- No persons --
 - (a) who has entered into, or contracted, a marriage with any person having a spouse living, or
- (b) who, having a spouse living, has entered into or contracted a marriage with any persons,

shall be eligible for appointment to any of the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible, under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 6. Power to relax.—Where the Central Government is of the opinion that a is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or entegory of persons.
- 7. Savings.—Nothing in these rules shall affect reservations, relaxation of age limit and other concessions, required to be provided for the Scheduled Castes, the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
