New Delhi, the 19th April, 1995

G.S.R. 228.—In exercise of the power conferred by the proviso to article 309 of the Constitution and in supersession of the North Eastern Police Academy, Barapani (Group 'C' posts) Recruitment Rules, 1989; No. GSR 143, dated the 17th February, 1989 except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules for regulating the method of recruitment to Group 'C' posts in the Ministry of Home Affairs, North Eastern Police Academy, Barapani, namely :—

1. Short title and commencement :—

- (1) These rules may be called the Ministry of Home Affairs North Eastern Police Academy

Barapani, Group 'C' posts Recruitment Rules, 1995.

(2) They shall come into force on the day of their publication in the Official Gazette.

2. Application.—These rules shall apply to the post specified in column 1 of the Schedule annexed to these rules.

3. Number of Posts, their classification and scale of pay.—The number of the said posts, their classification and scale of pay attached thereto shall be specified in columns 2 to 4 of the said Schedule.

4. Method of recruitment, age, limit, qualifications.—The methods of recruitment to the said posts, age limit, qualifications and other matters relating thereto shall be as specified in columns 5 to 11 of the aforesaid Schedule.

5. Disqualification.—No person—

- (a) who has entered into, or contracted a marriage with a person having a spouse living;
- (b) who, having a spouse living, has entered into or contracted a marriage with any person;

shall be eligible for appointment to the said posts:

Provided that the Government may if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, ex-

empt any person from the operation of this rule.

6. Power to relax.—Where Central Government is of the opinion that it is necessary or expedient so to do, it may by order for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

7. Savings.—Nothing in these rules shall affect the reservations, relaxations of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time.
