

G.S.R. 434.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules for regulating the method of recruitment to the post of Assistant Director (Information Technology) and Computer Programmer in the Ministry of Home Affairs, North Eastern Police Academy, Barapani, Shillong, namely:-



Short title and commencement.- (1) These rules may be called the Ministry of Home Affairs, North Eastern Police Academy, Barapani, (Group 'A' and Group 'B') posts Recruitment Rules, 2017.

- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of post, classification, pay band and grade pay or pay scale. The number of post, their classification, pay band and grade pay or pay scale attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 3. Method of recruitment, age limit, qualifications, etc.- The method of recruitment, age limit, qualifications and other matters relating to the said posts shall be as specified in columns (5) to (13) of the aforesaid Schedule.
- 4. Disqualification. No person,-
 - (a) who has entered into or contracted a marriage with a person having a spouse living, or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and there are other grounds for so doing exempt any person from the operation of this rule.

- 5. Initial Constitution.- The person holding the post of the Computer Programmer Group 'B' Non-Gazetted in level 7, on the date of commencement of these rules on regular basis shall be deemed to have been appointed under these rules and the service rendered by him in the said post on regular basis before the said commencement shall be taken into account for deciding the period of probation, seniority, pensionary benefits and eligibility for promotion to the next higher grade.
- 6. Power to relax.- Where the Central Government is of the opinion that it is necessary or expedient so to do, it may in consultation with the Union Public Service Commission, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 7. Saving.- Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Ex-serviceman and other special categories of persons in accordance with the order issued by the Central Government from time to time in this regard.

Note 1: The Departmental Computer Programmer in level 7 in the pay matrix with three years' regular service in the grade will also be considered along with outsiders and in case he is selected for appointment to the post, the post shall be deemed to have been filled up by promotion. Note 2: Period of Deputation (ISTC) including period of deputation (ISTC) in another Ex-Cadre post held immediately preceding this appointment in the same or some other organisation or Department of the central Government shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation (ISTC) shall be not exceeding 56 years as on the closing date of receipt of applications.
