Please refer to your application under RTI Act, 2005 dated 20/10/2016, the information as asked for are as under –

- 1. The information sought by you is very detailed and voluminous covering a sizeable time span of 36 years. It will unnecessary and disproportionately divert the resources of the organization. Therefore, as per Sec.7(9) of RTI Act and as per the judgment of CIC.in K Raman Vs Neyveli Lignite Corporation Ltd. (CIC-24-6-2008) the above information can't be given, however, if you want to inspect the records, it can be done on any working day after giving necessary inspection fee. For 1<sup>st</sup> hour inspection is free and for every subsequent hour, it is Rs. 5/- per hour as per RTI Rules.
- 2. Two posts of Assistant and two posts of UDC are lying vacant. However grounds for not filling the above vacancies can't be asked in RTI Act, 2005.
- 3. Your request letter dated 26/6/2015 is rejected by the Competent Authority.
