G.S.R. 995.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules regulating the method of recruitment to the post of Electrician and Carpenter (Group 'C' posts) in the North Eastern Police Academy, Barapani, name-

- 1. Short title and commencement.—(1) These rules may be called the North Eastern Police Academy, Barapani, Academy, Barapani, (Group 'C') Recruitment Rules, 1988.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number, classification and scale of pay.—The number of the said post, its classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.
- 3. Method of recruitment, age limit, qualifications etc.-The method of recrultment to the said post, age limit, qualifications and other matters relating thereto shall be as specified in columns 5 to 14 of the said Schédule aforesaid.

- (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to any of the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving.—Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard. time to time in this regard.

- supersession of the North Eastern Police Academy, Barapani, Group 'C' posts Recruitment Rules, 19th in so far as they relates to the post of Multigraph Operator, and the North Eastern Police Academ Barapani, (Group 'C', Recruitment Rules, 1988, except as respects things done or omitted to be do before such supersession, the President hereby makes the following rules for regulating the method recruitment to the posts of Electrician, Carpenter and Multi-graph Operator in the North Eastern Police Academy, Barapani, Shillong, in the Ministry of Home Affairs, namely:-
 - 1. Short title and commencement. (1) These rules may be called the North Eastern Polic Academy, Barapani, (Electrician, Carpenter and Multigraph Operator) Group 'C' Posts Recruitme Rules, 2012.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
 - 2. Application.- These rules shall apply to the posts specified in column (1) of the Schedule annexe to these rules.
 - 3. Number of posts, Classification and Pay Band and Grade pay or Pay Scale.- The number of posts, their classification and the pay band and Grade pay or pay scale attached thereto shall be as specified in columns (2) to (4) of the said Schedule.
 - 4. Method of recruitment, age limit, qualification, etc.- The method of recruitment, age limit, qualification and other matters relating to the said posts shall be as specified in columns (5) to (13) of the aforesaid Schedule.
 - Disqualification.- No person,-
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage, and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 6. Power to relax.- Where the Central Government is of the opinion that it is necessary of expedient so to do, it may, by order, for reasons to be recorded in writing, relax any of the provisions of theses rules with respect of any class or category of persons.
- 7. Saving.- Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Schedule Castes, Scheduled Tribes, and other special categories of persons in accordance with the order issued by the Central Government from time to time.
